CANCELLATION POLICY

NOTICE PROVIDED	REFUND AMOUNT
> 30 days prior to the start of the course	100% of tuition minus \$150.00 deposit refunded or credited to your account
14-29 days prior to the start of the course	50% of tuition minus \$150.00 deposit refunded or credited to your account
0-13 days prior to the start	No refund, no credit.
